Seek Medical Attention: If you or someone you know has been sexually assaulted, seek medical attention as soon as possible. If the survivor chooses not to report the assault to the police, please know, you are not required to file a police report in order to receive a forensic medical exam.

Medical attention will:

- Assess and treat any physical injuries
- Determine the risk of sexually transmitted diseases or pregnancy and take appropriate measures
- Gather evidence that may be used in criminal prosecution if the survivor chooses to press charges either immediately or at a later time. If you are unsure that you want to file a police report, evidence collected will be kept confidential until you decide to use it.

About Title IX

Title IX of the Education Amendments Act of 1972 prohibits sex discrimination (also known as sexual harassment and sexual misconduct) within CUSM's educational programs and activities. Specifically, Title IX states, "No person in the United States shall, on the basis of sex, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any education program or activity receiving Federal financial assistance". CUSM is committed to providing an environment that respects the dignity and worth of every member of its community, and strictly prohibits all forms of sexual discrimination, sexual harassment, and sexual misconduct that destroy the foundation of such respect and violate the sense of community vital to CUSM's medical education.

ADVICE AND YOUR RIGHTS

Sexual Assault Counselor: Local rape crisis centers will connect you with a sexual assault counselor/advocate to accompany you through a forensic exam, court proceedings, on-campus meetings, and law enforcement interviews. You have the right to a sexual assault counselor/advocate to provide you information on your rights and give you emotional support. Rape crisis centers are available 24 hours a day, 7 days a week.

To Preserve Evidence: You are strongly encouraged not to bathe, douche, smoke, brush teeth, or change clothes. If clothes have been changed, place original clothes in a paper bag (plastic bags damage evidence) and take them to the hospital. Physical evidence is most effectively collected within 24-48 hours, but some evidence may be collected for up to 72 hours.

Confidentiality: Although information provided to medical providers is generally protected by confidentiality, medical providers in California are required to notify law enforcement if a patient tells medical personnel that they have experienced sexual violence. Although the police may be present you are not required to speak with them.
